## Mentelle Neighborhood:

The following petition is provided for requesting the Division of Traffic Engineering to study the feasibility of installing speed tables on Aurora Avenue between Walton Avenue and Richmond Avenue. The petition area includes all properties in the neighborhood bounded by Walton Ave. (see enclosed exhibit as a reference). A total of 75 signatures out of 115 are needed to meet the 65% threshold in order to proceed with the study. **Only one signature can be applied to each property parcel.** 

Once a successful petition is produced, then the Division of Traffic Engineering will proceed to schedule the street for data collection. The data will then be processed and checked against criteria. The criteria used by the Division of Traffic Engineering are provided in the Neighborhood Traffic Management Manual. A copy of the manual is included.
